

Empanelment of Independent Expert (IE)

For Committee for Resolution of Stressed MSME Accounts up to Rs. 25 Crore at Head Office level.

Applications are invited from eligible candidates for engagement as Independent Expert (IE) to be inducted as a member of the committee to be formed at Head Office level of the Bank for resolution of stressed MSME accounts for revival and rehabilitation of MSMEs.

Eligibility: Retired Executive of any Bank other than UCO Bank, not below the rank of AGM and having exposure in credit.

Age: Maximum age will not be more than 65 years.

Remuneration: Fixed remuneration of Rs. 3500/- (Including conveyance & other expenses) per day irrespective of accounts/Sittings on a particular day. However in view of long distances to be covered in case of Metros & Major A class cities an additional amount upto Rs.500/-may be sanctioned at the discretion of the Bank.

Contract Period: Appointment will be on contract basis for a period of one year. Reappointment may be done on the basis of satisfactory performance.

Roles & Responsibilities: Participate in the Committee meetings for carrying out corrective Action Plan for studying the Techno Economic Viability of the project along with its feasibility and bankability and provide suitable inputs for revival and rehabilitation of the stressed MSME accounts.

Discontinuation /Termination of services: Bank may discontinue or terminate the services of IEE, if performance is not satisfactory and/or any other reason; bank does not require their services. One month advance notice is to be issued by bank & vice-versa, in case the IEE quits the job.

Mode of selection: Interview
